Notice under sections 708A(5)(e) and 708A(6) of the Corporations Act 2001 (Cth) (the Act)

Australis Oil & Gas Limited (ASX: ATS) (the **Company**) has issued 3,142,858 ordinary fully paid shares (**Shares**) as part of a placement to institutional and sophisticated investors. An Appendix 3B is also being released today.
