## **Vesting of Performance Rights**

Australis Oil & Gas Ltd ("Australis" or "Company") advises

- 5,097,257 performance rights (Employee Long Term Incentive Equity Plan granted in 2018, 2019 and 2020),
- 11,732,624 Fee Rights A (granted in 2020 to Non executive Directors in lieu of cash fees), and
- 42,877,432 Fee Rights B (granted in 2020 to employees including Executive Directors in compensation for salary reductions and other cash incentives forgone)

have vested effective 31 January 2021.

2,724,629 performance rights and 1,176,750 Fee Rights B have lapsed as a result of failure to meet the continued employment vesting conditions. 7,997,341 were exercised to meet employee personal tax obligations in North America upon vesting.
